Notice of Intention to Transfer for F-1 students

All students currently in F-1 status at any institution in the U.S. who plan to change from one school to another are considered transfer students for immigration purposes. If the student maintains valid F-1 status, he or she may transfer from one SEVP-approved school to another by following the transfer procedures outlined in 8 CFR 214.2(f)(8). It is the student's responsibility to maintain their F-1 student status and complete the instructions described below for a transfer.

If you are not currently in legal status, notify us to discuss your options.

To the student:

1. Notify your current school of your intent to transfer.
2. Complete section 1 of this form.
3. Have the designated school official at your current institution complete Section 2.
4. Return the form promptly to Solexian.

Remember:

Solexian cannot issue an I-20 until after the "release date" provided by your current school.
